

## ECO Flex: Householder Application Form

ECO Flex allows local authorities to extend the eligibility criteria of the Energy Company Obligation (ECO4) scheme. This form allows households to apply to **East Lindsey District Council** for the ECO Flex scheme as detailed in the Statement of Intent on the website: <https://www.e-lindsey.gov.uk/article/24146/Energy-Company-Obligation-4-ECO4>. Households are able to indicate on this form which of the four available routes they may qualify under and share their personal details with their local authority or eligibility assessor.

All potentially eligible households should apply through East Lindsey District Council, YES Energy Solutions or Everwarm Ltd to ensure that they can either benefit from the scheme or be assessed for eligibility under any other relevant programme.

<p><b>Route1: Income based using £31,000 gross income cap</b>            And must have an Energy Performance Certificate (EPC) rating of D, E, F or G for owner owner-occupied households and EPC rating of E, F or G for private rented sector households with an income less than £31,000. These health conditions may be cardiovascular, respiratory, immunosuppressed, or limited mobility related.</p>		
<p><b>Route 4: Bespoke Targeting</b> EPC band D-G owner-occupied households and private rented sector E-G households that are referred under Route 4: Bespoke Targeting. Suppliers and LAs can submit an application to ESNZ where they have identified a low income and vulnerable household, who are not already eligible under the exiting routes</p>
