## ISSUES BACKGROUND PAPER

July 2012

#### Introduction

- 1. The following document is a summary of the issues that have been raised through the various Issues related consultation exercises that the Council has carried out to inform the preparation of its Local Development Framework.
- 2. Three main strands of consultations have been carried out. The first was in March 2006, when the Council took the opportunity when consulting on its Statement of Community Involvement to ask about the issues facing East Lindsey. The second was a joint consultation on the review of the East Lindsey Community Strategy in April 2007. The third was the consultation on East Lindsey's draft Core Strategy in November 2009.
- 3. Respondents to the first consultation were given a list of issues to choose from and asked to select their top five. The selection of issues was drawn from a number of sources, such as the Community Strategy and a State of the District report the Council has commissioned. The summary from the first consultation shows the top five issues selected by each of the groups targeted; recent applicants and agents; attendees to workshop events run and other public responses from questionnaires to a random sample of households and online consultation. Below that are the free form answers from questions asked regarding issues we had missed and peoples wishes for the future.
- 4. These free form answers have been grouped where people have made similar comments and so form a representative sample of the issues that were raised.
- 5. Following from the March 2006 issues, this document sets out the responses to the joint consultation with the Community Strategy.
- 6. For each theme, people were offered a range of issues from which they chose their top three; they were also offered the opportunity to identify other missing issues under these themes. The results in the tables show the percentage of people who have identified each issue as important and the weight given to each. After this follows a free form section where people could identify solutions to each of these issues. For the purposes of this document, that section has been edited down to those issues which could be directly influenced by the LDF or those issues that could influence the preparation of the LDF. Comments that did not fit into either of these categories, for example on sentencing policy, healthcare on an individual level, alternative punishment for offenders or emotive comments that may offend, have not been include in the summary. The comments have also been grouped, so where a similar comment was made on a number of occasions, it has not been repeated.

#### **Issues Sources**

#### In conjunction with SCI Consultation

- 7. The Council carried out initial consultation on issues in conjunction with its early consultation on the Statement of Community Involvement. A questionnaire was sent to a random sample of 1,000 households and to 488 individuals and agents who have made recent planning applications. Parish Council's and interest groups were invited to workshops held in Horncastle, Louth and Skegness. Alongside this targeted consultation, the questionnaire was also available for completion on the Council's website.
- 8. All respondents were asked to select their top three issues from a selection offered to them. The table shows a summary of which issues respondents ranked in their top three issue:

- Exploit the economic opportunities of Tourism.

- Try to make the general public understand they have a responsibility in all areas ie planning, policing, health etc.
- Reluctance to allow building on village outskirts (affordable housing) and the very strict use of the 1995 local plan.
- Positive economy, including tourism.
- Vandalism.
- Disposal of rubbish -present policy needs to be 'joined up'.
- Crime.

- High Council Tax considering the amenities provided.
- The re-design of old farm buildings etc to domestic dwellings -told must be in keeping with the surrounding area which leaves no room for the imagination.
- Caravans.
- Green field developments.
- Tacky shops.
- Retaining unique beach huts.
- Out of character housing applications.
- Some properties being very run-down.
- A swimming pool would be very beneficial.
- The urgent need for Lincolnshire County Council and others to eliminate the traffic congestion on the roads of Horncastle.

10. Respondents were also asked, if they had a wish for the future of the District, what it would be:

#### **Applicants**

- Affordable Housing.
- Wider variety and better amenities.
- Speed control and road crossing on the A16.
- Better sporting facilities for all -not just Louth and Skegness. Not everybody can access your new proposed facilities.
- Provision of open space.
- Maintenance of roads and verges.
- Clean, tidy and free from vandalism.
- An improved quality of decision making in the District that is transparent, consistent and accountable.
- Good NHS facilities including dentistry and the maintenance & expansion of the Louth Hospital. Healthcare sites are a big issue in a very rural, large and geographically isolated district. Protect and support what we have.
- Economic growth -the area is poor -Large new industrial/manufacturing employer moving its base to Fairfield Industrial Estate in Louth.
- More control on farming activities ie chicken farms, noise from gas guns, speeding big tractors etc.
- Neighbours and local councils concerns carry more weight in matters such as 24hr drinking and the environment.

- The Council becoming more transparent in the way in which it conducts business and ensuring staff are more approachable.
- Sustained tourism to promote long term employment.
- Improvements to the sea front at Sutton on Sea eg the beach huts, planning permission is so complicated it is putting people off putting up new huts.
- Mains gas fitting.
- The planners could be changed to people who have an interest in architecture and preservation on communities and who are willing to discuss matters with applicants and the locals rather than stamp their opinion on a local matter.
- Consistency in decision making.
- Improvements to buildings to off-set the problems of climate change, which would therefore make most buildings more sustainable for the long term.
- Population growth in Horncastle (ie greater housing development) coupled with town centre growth (ie shops, offices etc). Higher calibre of shops.
- Rejuvenating Horncastle.
- Street cleanliness/road gulley cleaning to prevent flooding.
- A swimming pool.
- Better use of public money!
- No more development of characterless housing.
- An urgency in producing the LDF so that ELDC can move forward quickly.
- Re-opening of Louth Navigation Canal.
- Filling up the village making a community which would include pedestrian walkways and wider road access (Irby in the Marsh).
- Good dual carriageway road network.
- Create safe and sustainable communities in terms of energy efficiency, housing, employment, access to local services and good public transport to access non-local services.
- Truly regenerated rural economy.
- The setting up of a facility in Horncastle similar to the Wragby Centre.
- More new businesses being given planning permission for developments in Louth.
- Rural character sustained and enhanced in all aspects.
- School buses to get cars off the road taking children to schools. More should be done to make Mablethorpe a better place for our future generations.
- Listen to potential investors and respond more quickly and see real action in the form for development.
- Sustainable future, lifestyles and buildings.
- Public consultations ref planning issues on sensitive sites. Making sure that planning committee members are more in tune with policy and planning officers.

- Integration of modern architecture alongside Louth's existing architecture.
- Large open space where youngsters and others might learn to drive/ride off road, under age, with supervision of sorts Strubby airfield might be ideal for a small(ish) cardrome (locals only).
- Less Red Tape and bureaucracy from Central Government.
- Boston by-pass.
- Impartial planning decisions, not affected by disproportionate lobbying.
- Investment in business and things for the tourists to do.
- Stamp out crime (vandalism especially, most of which appears unresolved) and give us some police coverage that is effective. Close pubs at decent times.

#### Workshop

- Improve villages with permitting more development instead of spoiling small market town.
- Well designed housing.
- Affordable housing.
- Careful development without building on greenfield sites, particularly agricultural land.
- Real control over development which reflects the views of local residents.
- Pedestrian-friendly walkways and footpaths.
- More information & co-operation between the community and ELDC. A change in attitude of trying to achieve what local people want rather than imposing change upon us.
- Footpaths for local people to get to school safety footpath to dwellings on B1192 Langrick Church.
- Site and build a village hall for benefit of the Parish.
- The Planning Dept to be helpful, positive and forward thinking.
- Development at Sibsey.
- Road construction to bypass towns with the sensible application of speed limits eg why 30mph at schools on unrestricted roads at night or during school holidays when buildings are empty.
- A village hall in Hagworthingham.
- Larger Tesco store.
- A community park, Hemingsby Lane tip and the Wong.
- More development. Wish to develop some land at Wood Enderby & New Bolingbroke, Occupation Lane.
- I would hope you maintain the character of W.Spa so that the tourist potential is recognised without loss of space. Is it possible to receive minutes of Council meetings?
- More facilities for the young. Possibly a place to sit and talk, play music and have soft drinks.
- A vibrant town with a mix of all ages with 1st class amenities for all.

- Community shop to include banking, post office, doctors' surgery.
- Community shop/Bank/Post Office.
- Leisure/sports centre for young people and families and older people as well.
- Allow more bungalows of reasonable size and less large houses.
- Holt Lane footpath re-opened.
- Minor roads repaired.
- Better housing and car parking.
- Make information more accessible to everyone e.g. schools, young families and residents who are at work and unable to attend meetings like this. Maybe have information available in supermarket car parks. Interactive webcam for planning applications works well in other areas for interested public.
- Spending the money (rates and taxes) economically and wisely.
- Keep the character of the villages. Do not let them expand and develop so they lose their character.
- Parking in Horncastle.
- Stop ALL new builds in rural areas until the infrastructure has caught up to be able to cope with the increase in population. In particular, provision of health care and policing.
- Better planning for a 'village'-not cramming rows of town houses and huge executive houses into small spaces which look completely out of place.
- Pedestrianisation of parts of Horncastle Town Centre, via suitable diversion of through traffic, especially HGVs.
- I want to see my land in the future plan (land at Langton Hill, Hornscastle/Grainthorpe).
- No over-development. Any development sympathetic to the local area.
- Retain local character.
- Equality of services provided in the district. The same services for small communities as there are for larger ones.
- Safer roads.
- Restriction on chicken farms/intensive livestock units and chemical input into land/watercourses by farmers. More organic/natural farming promoted/encouraged.
- Ban the construction of wind turbines in Strubby.
- Economic development.
- Reduction in green fields destruction.
- Highways kept in better order. Hedges cut back for better vision for other road users. Drainage -roads flood whenever it rains, even if not excessive amounts.

- Easy access to Planning Department and clear advice and consistency in planning approvals.
- Concentrate on nice, suitable housing instead of the Council being greedy and demanding lots of houses on small plots that look unsightly.
- Care taken on planning issues so that any new housing/building in villages is in proportion to the plot and fits in with the character of surrounding properties.
- It is vital that Anglian Water is included at a much earlier stage -in fact at the Planning approval stage -of all new developments even if there is no current requirement for 'ELDC' to do so.
- Make it mandatory that all planning applications are produced or, at least, vetted by a qualified designer. This system works well in Spain.
- There seems to be no organizational, co-ordinated development plan.
- Provision and donation of land for self-build.
- Carbon footprint must be top priority and reasonable living costs.
- No more caravan parks that remain empty half the year.
- Ensure that building cheap housing does not create unsatisfactory building standards.
- New development should not be built in the flood plain.
- More housing near coast for people to move there (re work).
- Must prioritise quality, rather than speed, of decision making on planning applications, giving time to negotiate good -rather than "not bad enough to refuse" –design.
- I would hope that planners could be more flexible in what they agree to. Practically the whole of Louth seems to be a conservation area now!

#### Growth of towns and villages

- Majority of planning applications in the villages are turned down stating "unsustainable development" however this is due to the fact that villages have not been allowed to develop to provide a sustainable environment.
- Properties in the villages are too expensive for young people.
- Local organisations and facilities are closing down as there are not enough people to support them.
- Stop building before you mess it all up. Too much building is destroying the village.
- Amenities and infrastructure are needed to match new development e.g. water pressure is very low at certain times, shops and employment need to be available.
- Housing is being restricted because of the fear of climate change yet tourism projects are being touted for regeneration, more people travelling, fewer residents encourage home building.

- Towns and villages should only be allowed to expand if and when jobs are available in the immediate area, to accommodate the new influx.
- Allow superstores in it will benefit all.
- Not necessarily bigger but better.
- People are more important than wildlife at times.
- Encourage small village development so that they too can develop selfsufficiency, instead of keeping development to existing sustainable towns and villages.

#### Retaining local shops and services in towns and villages

- Supermarkets take away variety and competition from small local shops.
- Must not let Post Offices close.
- We need to retain local services and indigenous shops in order to retain local character in our area.
- Help for pubs/village halls/petrol stations etc to develop their facilities.
- Allow additional housing development in villages in order to support and retain local shops & services in those villages currently designated as 'unsustainable'.
- Encourage diversification through eco-tourism.
- Please let us remain a market town. No big supermarkets are required.
- Those without transport need shops and post offices etc.
- Poor parking drives people to shop in large supermarkets normally situated away from traditional city centres.
- Less national chain stores, more farmers' markets.
- Ensure supermarket development is in town centres and not on outskirts of town.
- More public transport.
- Encourage more tourism to Wolds area. Create more buoyant economy through more businesses and jobs.
- Let the big shops/chain stores/supermarkets come to the town.

- Put an end to all this housing development, don't develop villages too much.
- New housing estates should have to have either doctor/dentist or shops onsite.
- Reduce the tendency for centralisation -first everything goes to Skegness, then Boston, then Lincoln, leaving little elsewhere.
- An integrated retail plan that ensures that towns have the right mix of local/multiple outlets.
- Encouragement for smaller new businesses to be set up in villages.
- Consider the interdependence of local shops and services.
- Communicate facilities between service providers.
- If local shops are retained less fuel will be used by motorists.

#### Protecting local character -both the natural and the built environment

- Accepting that the 3rd tier of local government (town/parish council) has more knowledge on these issues and act accordingly.
- Protect green space in town and villages.
- Check all plans carefully and be prepared to demolish if buildings have been built without planning permission and they are not in keeping with the environment.
- Forward plan for what we want the countryside to look like in 10/20/30 years.
- Don't over develop market towns.
- Build more in towns. Leave villages as they are as the character is being lost.
- Ensuring protection for the natural environment through biodiversity.
- Include social aspects (e.g. access, community involvement) as well.
- Discourage larger supermarkets.
- If you want to protect a unique resource then you don't develop it to become like everywhere else.
- Don't build social housing everywhere.
- Local distinctiveness.
- We take the time to look for suitable places to build houses, not just anywhere.
- Use brownfield land.
- More laws to protect the environment and historic buildings and more aid to renovate these buildings.
- Less infilling/over intensification.
- Need to use Landscape Character Assessments and Historic Landscape Characterisations tool in decision making.
- Sustainable development.
- Build low cost housing.
- Strict building regulations.
- Only allowing development within town and village boundaries.
- No green field development and no industrial use of countryside (including intensive farming).

- More restoring. Less building new.
- More hedges to be set around fields/removal of wooden fences.

#### Development in the countryside

- Unhappy with building in the countryside.
- If you over develop the countryside soon won't have a countryside.
- Make more use of redeveloping brown field sites, particularly those in or around towns, nearer to jobs, transport links and shops.
- Looser planning rules, build new houses in countryside.
- Farm/rural diversification.
- Increase development of affordable housing.
- Stop planning permission that allows people to turn small bungalows etc into large town houses.
- Stop large developers building.
- More development in the countryside, far from being unsustainable, would help to increase the sustainability of rural services.
- Look to developing areas of green field rather than previously developed land in inappropriate locations for wholly sustainable communities.
- Should be allowed to develop on own land if to local benefit e.g. granny annexes/bungalows for the kids etc.
- A more spatial planning approach is required to development throughout East Lindsey instead of a piecemeal approach. Development of spatial planning tools should be a priority for land and sea.
- Encroachment on the open countryside should be taken as a serious issue, and the loss of unique habitats.
- More wind turbines.
- Valuing the coast and coastal habitat.
- Better parking or pedestrianisation for disabled access.
- Homes for locals and business development to provide jobs.
- High-density building is unnecessary in a county like Lincolnshire.

#### Access to shops and community facilities

- Build a motorway connecting the M180 with M11 an East Coast access road!
- More national companies would increase wages.
- Build a designer outlet.
- Allow realistic development of facilities in towns to serve local villages.
- Need a supermarket.
- Let us have out of town shopping.
- Avoid allowing planning consent for 'out of town'.
- Community facilities in rural areas need to be retained.
- Improve public transport.
- What shops and facilities?
- Improve town centres for the pedestrian/wheelchair users.
- Ensure new builds have access to shops and community services.

- More and cheaper (free) car-parking.
- Allow more growth the shops will follow.
- Need to balance new house build with new facility build.
- Allow fast food outlets in will attract passing traffic into town.
- 12. Responses received during the above consultations were taken individually through the Council's Planning Policy Committee, where similar issues were raised responses were grouped unless they were the same comment. All comments received during the Issues consultations were taken into account during the preparation of the Councils Local Plan which will go out to public consultation in May 2016 before pre-submission toward the latter part of the year.
