

1.0 INTRODUCTION

- 1.1 A key objective of the planning process is to promote the sustainability of settlements through the three dimensions identified in the NPPF i.e. economic, social and environmental.
- 1.2 The Local Plan aims to protect and enhance the role of green-spaces and their quality and distinctiveness as part of the area's landscapes, townscapes and historic environment.
- 1.3 In Chapter 2 the Core Strategy notes that:-

'In medium and small villages, some open gaps have an important visual meaning, adding to the rural character of those settlements and it is felt that their retention is important. If these open spaces begin to be lost, gradually the character of the settlement will change and over time they will become less rural in appearance.' (P.30 para 2).

- 1.4 This thread is picked up in Chapter 3 of the Plan Raising the Quality of Our Built Environment. Amongst its' objectives is 'Development ... enhancing local distinctiveness and quality of life, and for development to improve the character and quality of its surroundings and the quality of the built environment.'
- 1.5 Paragraph 3 of the Chapter identifies the role of good design not just in terms of building but also in a requirement that it responds 'to the established form and pattern of development, to have a sense of character and include the spaces between buildings'. Reference is also made to the importance of design in protecting and managing change within the wider landscape. An extract of this section from the text accompanying the Policy is set out in Appendix 1 of the report.
- 1.6 Policy SP25 (SP25) Green Infrastructure deals specifically with green spaces and sets out the approach that will be taken to delivering a network of accessible green infrastructure by protecting existing sites and maximising new and enhanced areas of green space.
- 1.7 The approach the Council has used to interpret the role of greenspaces, and the importance of maintaining significant natural, seminatural and built features in the local landscape where they contribute to local character is set out below in Section 2.
- 1.8 It sets out how individual sites in the Settlement Proposals, reflect the Policy criteria and contribute to sustaining aspects of local distinctiveness.
- 1.9 The list is not exhaustive, a site may fulfil more than one criterion and, importantly there will be sites in the smaller settlements not identified in the Plan, that are equally deserving of protection.

1.10 Recognising this, Policy SP 25 (SP25) states 'In the case of sites not identified on the Inset Maps, development will only be permitted on open spaces provided unacceptable harm will not be caused to their appearance, character or role'. The Policy criteria are set out in the following section.

2.0 APPROACH

- 2.1 As part of the background to the Local Plan the Council undertook an audit of Recreation and Open Spaces. That audit identified over 190 green spaces deemed to be of character value. For each site their role and their contribution to the quality of the local environment was recorded.
- 2.2 The description of the role they play has subsequently been refined to establish the criteria for identifying sites to be safeguarded by Policy SP25 Green Infrastructure, these are set out in the criteria 2 of the policy. This is then applied to each site in the table below.
- 2.3 Those policy criteria are where a site provides:
 - a) the setting for a designated or non-designated heritage asset;
 - b) an important element in the street scene or a well-defined visual relief in an otherwise built up frontage; particularly in the case of ribbon development extending into the countryside;
 - c) a locally important habitat;
 - d) a prominent site at the entrance to settlements that provides the setting for the built environment;
 - e) a frame for or enabling an important view;
 - f) a landscaped area forming part of structural open space within a development site;
 - g) informal amenity or recreation space; or
 - h) formal public green-space, such as parks and gardens and allotments.
- 2.4 Table 1 below identifies the areas of green-space shown on the Settlement Plans, by Location, Name, Site Number, Address and the Type (function) of the space based on the criteria of the Policy.
- 2.5 The table includes churches and cemeteries, allotments and other informal spaces but does not include sports grounds, which were

subject to a separate assessment and are covered in Chapter 13 – Open Space, Sport and Recreation in the Local Plan.

APPENDIX 1

Extract from Design Policy text

- 2. The environment should be valued for its own sake and there is a widespread acceptance of the importance of the familiar and cherished local scene. The distinctive character of each town and village is a source of local identity and pride, reinforces community confidence, and enhances quality of life for the residents of the District. High quality environments also play a significant role in attracting visitors and investment. Where prepared, Town or Village Design Statements will be a material consideration in the planning process.
- 3. Good design is important in shaping the places where we live, work and undertake leisure activities. It is not just about buildings. Development should respond to the established pattern and form of development, have a sense of character and include the spaces between buildings, how they relate to each other and the street, the different uses of buildings and how they operate, and access around and between towns and villages. Good design is also an important factor in protecting and managing change within the wider landscape. Development proposals must show how they have taken into account and respected the distinctive character of their setting. Where appropriate the Council will encourage developers of major development to enter into a Planning Performance Agreement and agree a set of principles around good design.
