Executive Summary

- An ecological survey of 199 sites in East Lindsey has been carried out in 2008 and 2009, and the results used to identify those that potentially qualify for designation as Local Wildlife Sites.
- An additional 17 sites were not surveyed due to access permission being refused or sites being otherwise inaccessible.
- Some 99 sites (49.7% of the total) were evaluated as meeting one or more of the Local Wildlife Site selection criteria. Of these 49 qualified under woodland criteria (WD1/1b, WD2, WD3, WD4, WD5), 21 under neutral grassland (NG1), four under calcareous grassland (CG1), two under heathland/ acid grassland (HE2), two under flowing water (Flo1), seven under standing water (Sta2), two under swamp, marsh and fen (Sw2), two under coastal and estuarine habitats (Co3) and ten under habitat mosaics (Mos1, Mos2, Mos4).
- It is recommended that these 99 sites be given consideration by the Local Wildlife Sites Panel for designation as Local Wildlife Sites and subsequent incorporation into the Local Development Framework for East Lindsey.

1. Introduction

The Ecology Consultancy was commissioned by East Lindsey District Council to carry out a review of a number of existing and candidate Sites of Nature Conservation Importance (SNCIs) during 2008 and 2009. A total of 216 sites were scheduled for survey.

The purpose of the review was to inform the emerging Local Development Framework by assessing the sites against the recently produced guidelines for the selection of Local Wildlife Sites (LWS) in Lincolnshire (Lincolnshire Biodiversity Partnership 2006, 2008). These have been prepared by the Biodiversity Partnership in response to guidance produced by DEFRA on Local Sites – Guidance on their Identification, Selection and Management (DEFRA 2006, 2008). The aim of this guidance and the selection criteria for Lincolnshire is to make the selection of Local Wildlife Sites more consistent and robust by basing it on up-to-date survey information and defined criteria.

This report provides an overview of the sites surveyed, the habitats and noteworthy species recorded and the evaluation of sites as those that do and do not currently qualify as potential Local Wildlife Sites. The full survey information, including a record card, species list and summary sheet for each site, is available separately.

2. The Project Brief

The study originally called for a review of some 224 existing and candidate wildlife sites in East Lindsey. Eight of these were later removed from the list as up to date information was already available for these sites. This gave a total of 216 sites to be surveyed during 2008-2009 (Appendix 1).

The process of designating sites as Local Wildlife Sites in Lincolnshire is intended to be a four stage process. Of these, the first three stages are within the scope of this project. The first stage required direct field surveys of each site to describe the habitats present and to generate an inventory of vascular plant species present along with incidental records of other plants, fungi and animals. Second, each site was then evaluated against the criteria for the selection of Local Wildlife Sites and sites that satisfy one or more criteria were identified. Third, for each site a portfolio of documentation was prepared for submission to the Wildlife Sites Review Group, including a site record sheet with an account of the habitats and other noteworthy features, a species list, and an overall summary. A GIS layer showing the boundaries of all sites surveyed and any suggested boundary modifications was also produced as part of this work package.

All of the information gathered is to be submitted to the Local Wildlife Sites Panel of the Lincolnshire Biodiversity Partnership and to East Lindsey District Council. The Local Wildlife Sites Panel will use this information to assess each site against the selection criteria for Local Wildlife Sites and will then make a recommendation as to whether or not they should be designated as a non-statutory Local Wildlife Site (LWS). Landowners/managers will be informed of the Local Wildlife Sites Panel's recommendation and, should the site be recommended for designation as a LWS, given the opportunity to make observations on the application of the selection criteria by the Lincolnshire Biodiversity Partnership Steering Group.

A copy of all of the survey information gathered will be lodged with the Lincolnshire Environmental Records Centre (LERC), for incorporation into their database. In addition, each landowner/manager will receive a copy of the survey information pertaining to their land.

The field surveys were undertaken following standard Phase 1 habitat survey methodology (JNCC 1993) and the protocols outlined in the guidelines for the selection of Local Wildlife Sites (Lincolnshire Biodiversity Partnership 2006, 2008). A structured walk was carried out through each site, with the habitats and other features being recorded on a standard LERC recording card. A list of vascular plant species identifiable at the time of the survey was also compiled, using the Botanical Society of the British Isles (BSBI) recording card for North Lincolnshire. Incidental records of bryophytes (mosses and liverworts), fungi, invertebrates, fish, amphibians, reptiles, birds and mammals were made where appropriate; however, detailed surveys of these groups were beyond the scope the project. It should be noted that for some habitats the selection criteria include the quality of the assemblages of fish or invertebrates, as determined by their community conservation score. This restriction is of particular relevance to the freshwater and swamp, marsh and fen habitats, and may result in some sites that are of lower value for vascular plants but of potential significance for fish and invertebrates being undervalued by the current process. The status of these sites may be reviewed as further information is gathered and made available to the Wildlife Sites Panel from other sources, e.g. the Environment Agency.

3. Results

SITE SURVEYS

Of the 216 sites scheduled for survey over the two year period 175 were surveyed in full and a further 24 were surveyed from adjacent land. It was not possible to survey the remaining 17 sites due to lack of access. Thus a total of 199 sites were surveyed during 2008-2009.

HABITATS

The 199 sites surveyed fell into nine broad categories as shown below. Several of these categories include more than one habitat type; for example a number of the rivers support wetland and grassland habitats. The categories chosen are intended to give an indication of both habitat type and site usage (see Figure 1, Table 1).

Figure 1: Frequency of main habitat categories recorded

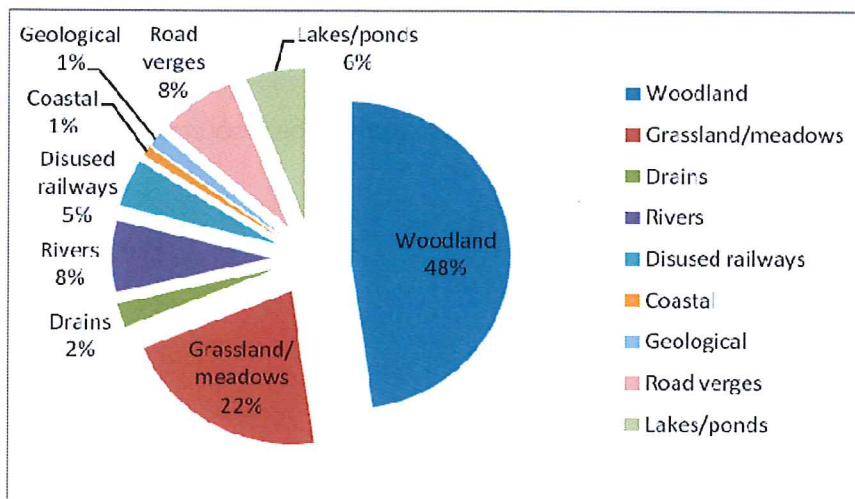

NOTEWORTHY SPECIES

A number of noteworthy species were recorded during the survey and these are listed in Table 2 below. Of these, the most significant are the records of: the local sub-species of yellow archangel *Lamiastrum galeobdolon* ssp. *galeobdolon*, greater butterfly orchid *Platanthera chlorantha* and shepherd's pennycress *Teesdalia nudicaulis*, all of which are listed as Vulnerable in the latest vascular plant red data list for Great Britain (Cheffings & Farrell 2005); and heath cudweed *Gnaphalium sylvaticum* and fine-leaved sandwort *Minuartia hybrida*, which are listed as endangered; all the other noteworthy species are listed as being of Least Concern.

CONSTRAINTS

Timings

In most cases, the survey was confined to a single visit. The plant lists should therefore not be treated as comprehensive, but rather as a representative list of species evident at the time of survey. Timing of the survey will be a particular constraint for habitats with species that flower early in the season and then disappear (e.g. some woodland ground flora species).

Obtaining access permission for some sites proved to be a lengthy process and as a result some sites could not be surveyed until October. This is outside the normal survey season and this should be borne in mind when assessing the results for these sites.

Surveys of some of the grassland sites were constrained by hay cuts having recently taken place or the sward being closely grazed.

Surveys of the active railway sites were constrained by Network Rail requirements and limited access.

Access

Of the total of 216 sites scheduled for survey, 17 could not be assessed. These included 15 sites (7%) owned by nine landowners who refused to give permission for surveyors to access the sites and a further two sites (John Holden charity meadows 811 & 808) where it was not possible to contact the landowner or to view the sites from public land (Table 3). It is therefore recommended that consideration of these sites is deferred until such a time as the landowner's permission can be obtained and a full survey can be carried out. There were a further 24 sites for which it was not possible to contact landowners for several reasons. In these cases it was possible to

assess the sites from adjacent land and as such recommendations for these sites have been given.

Of the 24 remaining sites for which landowners could not be contacted, 17 were rivers and railways which are thought to belong to a large number of landowners. As such it was not practical to locate, contact and obtain permission from each of these owners individually, rather it was considered that carrying out the surveys from public footpaths, roads and bridges would provide sufficient detail to enable an evaluation of the wildlife value of the site. There were a further nine woodland and grassland sites for which land owner details could not be obtained or where the likely landowner details were known but no responses were given to our letters and phone calls, again these sites were assessed from public access points. These sites are listed in Tables 4 and 5 below.

4. Site Evaluation

Of the 199 sites surveyed, a total of 99 (49.7%) were evaluated as satisfying the requirements for Local Wildlife Sites on one or more criteria, including main and additional habitats. These sites are therefore recommended for designation as Local Wildlife Sites; see Appendix 2 for a full list of these.

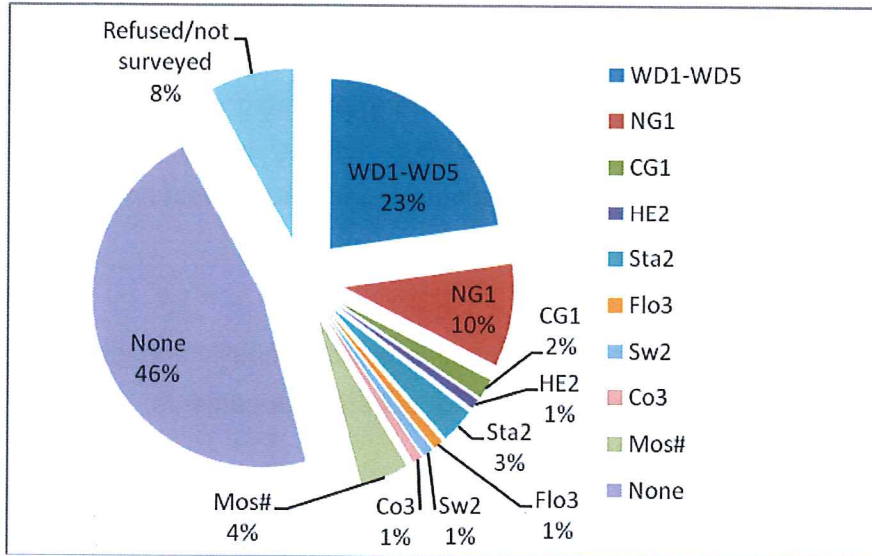

A total of 100 (50.3%) sites did not meet any of the Local Wildlife Sites criteria on the basis of the results of the current survey (Appendix 3).

Of the 100 sites that failed to qualify, 17 may qualify if additional surveys were carried out at a more appropriate time of year. These sites are listed in Table 8.
