As drafted the text refers to Red-Amber-Green (RAG) rating presented in the Study for Mareham Le Fen but does not clarify what is meant by each rating. For example reference is made to potential sewage treatment upgrade and foul sewerage network improvements in this catchment. It is therefore suggested that the wording be amended to make the plan effective.

treatment upgrades at Mareham Le Fen Water Recycling Centre (WRC). Any further investment which is required at Mareham Le Fen WRC would be made by Anglian Water through their business planning process. The							
Study identifies a need for improvements to be made to the foul sewerage network to accommodate the sites at Mareham Le Fen subject							
to a more detailed assessment as part of the planning application process. There is currently capacity within the existing water supply network to accommodate sites at Mareham Le Fen.'
