At the Examination hearing it was agreed by the Inspector that all sites referred to by Policy SP24 should be included on the maps in order for the policies to be duly enacted.

The Policies Map now appears to have included all Local Sites (although the scale makes this difficult to be certain), but international sites have been missed.

These international sites include SACs, SPAs and Ramsar sites. These almost exclusively overlap with the SSSI designations on the coast so a means of adding these designations with clarity should be determined.

A lack of these designations on the Policies Map means that the Plan is not:

- Legally compliant because: policies and proposals to protect the integrity of internationally important nature conservation sites will be ineffective because they are unaware of the presence of such sites.
- Sound because: it is not effectively enabling the delivery of sustainable development in accordance with the policies in the NPPF, in particular paragraphs 7, 17, 109, 110, 117 and 118
