At the Examination hearing it was agreed by the Inspector that all sites referred to by Policy SP24 should be included on the maps in order for the policies to be duly enacted. The GLNP has two points to make on this modification:

Incorrect shading of Ancient Woodland

This map identifies a number of areas as Ancient Woodland however these do not match the Natural England Ancient Woodland Inventory. Instead they seem to match the allocations for Protected Open Space. The GLNP suggests that these areas have been incorrectly shaded.

The error means that the Plan is not:

<u>Unclear shading of overlapping designations</u>

Similar to the point made on SP24, the map includes a LWS that is also ancient woodland in the west. From the shading of this site it is not clear that it is both of these designations and as such Policy SP24 cannot be effectively enacted.

The lack of clarity on these designations means that the Plan is not:
