Dear Mr Cox

Thank you for your email.

I am sorry but it is not clear from your email if you are making a representation on the Main Modifications to the Local Plan. If this is the case then you need to read the guidance which is available on the Council's website and reference your comments to one of the Main Modifications.

The Local Plan has been out for consultation on a number of occasions, the last two times in June 2016 and November 2016, it has also been subject to Public Examination Hearings in July, August and October of 2017. It is now not possible to make broad changes to the wording of the Plan as it moves towards its Adoption. The Core Strategy is an over-arching policy document and does not drill down into specifics of areas as such a sentence drawing attention to the Louth Canal would be sufficient. Development which supports tourism would be supported by the Council providing it conformed to the Local Plan and National Planning Policy and more strategic a policy is means that it tends to be more flexible for decision making.

If you wish to make a representation on one of the Main Modification then please can you do this by the 16th February. If you however, just wish the comments you have been made to be passed onto the Local Plan Inspectors please can you let me know.
